game zones to present information in a lively and informative manner. Speaking at the inauguration, Singh stressed the importance of responsible development

in the face of a growing economy. Singh said, "It is the developed countries who need to cut down their emissions first. Around 85 per cent of the carbon dioxide load in the atmosphere is due to the path of industrialization followed by developed countries. India's population is 17 per cent of the world population while our contribution to carbon dioxide load is only 3.5 per cent." Singh added, "Even now, our per capita emissions are one third of world average, while that of developed countries is three times the world average. The Developed countries used fossil fuels for developing their economies but they want to tell us that we should not use coal. It is the Developed countries that need to cut down their emissions first." "We will not compromise on the electricity needs of a growing economy, but we will do it responsibly," he affirmed. The minister underlined India's commitment to achieving its climate goals, pointing out that the nation has consistently surpassed targets set at international forums. Singh said, "We need to develop. At the same time, we will do that responsibly. We were nine years ahead in achieving the Nationally Determined Contributions (NDC) target of having 40 per cent of installed power capacity from non-fossil-fuel sources by 2030.
